### **Community Protection**

- I will not have any contact with the victim(s) or co-defendant(s), if any, without the permission of my Probation Officer.
- I understand that my Probation Officer may visit my home, school, or place of employment at any time and may search my residence, motor vehicle, school facility, or locker at any time.

### **Accountability**

- I will comply with all City, State, and Federal Criminal Laws and abide by any written instructions of my Probation Officer. I will immediately notify my Probation Officer of any arrests or investigations by Law Enforcement Agencies.
- I will abstain from the unlawful possession or sale of narcotics and dangerous drugs and controlled substances within the meaning of the Pennsylvania Crimes Code, Controlled Substance, Drug, Devise, and Cosmetic Act unless prescribed for me by a licensed physician.
- I will submit to random drug and alcohol screening.
- I will abstain from the unlawful purchase, consumption, or transportation of liquor, malt or brewed beverages within the meaning of the Pennsylvania Crimes Code Section 6308.
- I will not associate with anyone on probation and parole.
- I will participate in the Community Court Resource program in my school district.

**Competency Building**

- If I am suspended from school or I find it necessary to miss school, I will notify my Probation Officer immediately.
- I will make every effort to find full-time employment, enroll in an educational program, or do both.
- I will participate in any treatment, counseling, or competency development program recommended or provided by the Court.

**Community Service and Restitution**
