LEGAL ADVICE FOR \$30.00 FOR LAWRENCE COUNTY RESIDENTS

If you are a Lawrence County resident, you may be eligible to receive up to one half hour of legal advice from a participating private attorney for just \$30.00.

The attorneys named on the attached list have indicated an interest in participating in this program, which is sponsored by Neighborhood Legal Services Association. However, there is no guarantee that any attorney on this list can assist you and NLSA makes no representations regarding the qualifications of the participating attorneys.

Please follow these instructions:

1. Select an attorney from the list who is interested in giving advice in the legal area in which you need help. Call said attorney's office for an appointment and tell the secretary that you have a letter for a \$30.00 advice appointment. (If the attorney is unavailable, try calling someone else.) Get directions to the attorney's office.
2. Present this letter to the attorney at the beginning of your appointment. Otherwise, the attorney may charge his or her regular fee for service. The \$30.00 fee must be paid at the time of your appointment.

The participating private attorneys look forward to serving you.

You may call NLSA at 658-2677 for help if you cannot afford an attorney and you need legal help in the following:

- *to obtain a Protection From Abuse Order, Child Support, Divorce, Custody or Visitation.
- *to defend an eviction, lockout, utility shut-off, mortgage foreclosure, Sheriff's sale, garnishment, or divorce.
- *with a food stamp, cash assistance, medical assistance, SSI, Social Security, or Unemployment Compensation problem.
